8. REPORTS:

- Lengthsman Cllr Lamont reported that the LM continues to work diligently and responds to work requests efficiently, and it was agreed his contract is renewed for 2025/26.
- Highways Cllr Rees met with WCC and the following were noted:
 - > New 30mph speed roundel (line markings) locations were agreed
 - > Drain under footway and verge (A4104) to be jetted
 - Awaiting posts for new VAS signs to be installed it is hoped that the existing sign could be used near Defford Church – to investigate if speed can be altered from 40 to 30mph
 - A competition for the school children to design a suitable SLOW poster which we will get made into signs for lamp posts. It was agreed that 2 x £15 book tokens be purchased for the winners.
- Traffic Calming Cllr Robinson made reference to faded line markings in Besford the clerk would request these are re-painted.
- Smart Water Cllr Hale reported that there were only 80 SW kits left and these would be stored in the VH. The SW signage is now in place.
- Wychavon District Council Workshops: Cllrs Rees and Lamont attended a recent event at WDC:
 - Neighbourhood Plan agreed there was little enthusiasm to pursue this.
 - Rural Transport to be posted on FB that Pershore Volunteer Centre are available to transport residents, but there is a charge

9. MILLENNIUM GREEN:

- Benches new composite benches would be ordered and installed at the same time as the repairs carried out on the play equipment. Spares have been ordered and await delivery
- Mole problem has been attended to
- New equipment it was agreed that there was space for a new piece of equipment should funds allow.
- Pitch levelling it was agreed that the football pitch was in need of levelling off. Cllr Soukup to estimate how much top soil was needed
